1. **RAKSIRANG RURAL MUNICIPALITY, CHAINPUR, MAKAWANPUR** invites sealed bids or electronic bids from Nepalese eligible bidders for the construction of the following road construction project packages from National Competitive Bidding procedures.
2. Eligible Bidders may obtain further information and inspect the Bidding Documents at the office Of **RAKSIRANG RURAL MUNICIPALITY, CHAINPUR, MAKAWANPUR** or may visit PPMO website www.bolpatra.gov.np/egp.
3. A complete set of Bidding Documents may be purchased *package wise* from the office **RAKSIRANG RURAL MUNICIPALITY, CHAINPUR, MAKAWANPUR** by eligible Bidders on the submission of a written application, along with the copy of company/firm registration certificate, and upon payment of a non-refundable fee of **Rs. 5000.00 for each package** till **2075/12/05** during office hours.

Or

Bidder who chooses to submit their bid electronically may purchase the hard copy of the bidding documents as mentioned above or may download the bidding documents for e-submission from PPMO's Web Site www.bolpatra.gov.np/egp. Bidders, submitting their bid electronically, should deposit the cost as specified above of bidding document in the Project's Rajaswa (revenue) account as specified below and the scanned copy (pdf format) of the Bank deposit voucher shall be uploaded by the bidder at the time of electronic submission of the bids. 4. Pre-bid meeting shall be held at **RAKSIRANG RURAL MUNICIPALITY, CHAINPUR, MAKAWANPUR** at **12:00 PM on 2075/11/26**
5. Sealed or electronic bids must be submitted to the office **RAKSIRANG RURAL MUNICIPALITY, CHAINPUR, MAKAWANPUR** by hand/courier or through PPMO website www.bolpatra.gov.np/egp on or before **12:00 PM** on **2075/12/6**. Bids received after this deadline will be rejected.
6. The bids will be opened in the presence of Bidders' representatives who choose to attend at **13:00 2075/12/06** at the office of **RAKSIRANG RURAL MUNICIPALITY, CHAINPUR, MAKAWANPUR**. Bids must be valid for a period of **90 days (2076/03/06)** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in .pdf format in case of e-bid, amounting to a minimum of as prescribed in **table** which shall be valid for 30 days beyond the validity period of the bid .
7. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
8. The bid security guarantee shall confirm to the standard format as specified in the bid document and that issued only by the commercial bank approved by Nepal Rastra Bank shall be accepted by the employer. The package wise details of the contract is given below.
