### Invitation for Bids for the Procurement of Works under Lump Sum Contract (Construction Turnkey Package [CTP])

1. **The Government of Nepal (GoN) / Raksirang Rural Municipality** has allocated funds towards the cost of **Chainpur Aldamar Suspension Bridge** and intends to apply part of the funds to cover eligible payments under the Contract **for the Supply, Fabrication, Transportation, Erection & Construction of Chainpur Aldamar Suspension Bridge in Lump Sum Contract** Bidding is open to all eligible Nepalese Bidders.
2. The **Raksirang Rural Municipality** invites electronic bids from registered contractors for the construction of the following Long Span Trail Bridges (LSTB) on Construction Turnkey Package (CTP) basis from eligible Civil Contractors under National Competitive Bidding – Single Stage Two Envelope Bidding procedures. Bidders requirements are given below. Detailed Evaluation and Qualification Criteria are provided in Section 3 of the Bid Documents.
3. Eligible Bidders may obtain further information and inspect the bidding documents at the **Office of Rural Municipal Executive, Raksirang** or may visit PPMO e-GP system [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp).
4. A complete set of Bidding Documents may be purchased from the **office of Rural Municipal Executive** by eligible Bidders on the submission of a written application, along with the *copy of company/firm registration certificate*, and upon payment of a non-refundable fee of NRs. **5000** till **2075/11/09 during office hours**. To submit the bid electronically, bidders may purchase the hard copy of the bidding documents as mentioned above or may download the bidding documents for e-submission from PPMO's e-GP system [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp). Bidders, submitting their bid electronically, should deposit the cost of bidding document in the Project's Rajaswa (revenue) account as specified below .

5. Electronic bids must be submitted to the office of *Municipal Executive* through PPMO's e-GP system [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp) on or before **12:00** on 2075/11/09. Bids received after this deadline will be rejected.
6. Bids will be opened in the presence of Bidders' representatives who choose to attend at **13:00** on **2075/11/10** at the office of **Rural Municipal Executive, Raksirang**. Bids must be valid for a period of **90 days** after bid opening and must be accompanied by bid security of NRs. 560,000.00 which shall be **valid for 30 days** beyond the bid validity period.

7. If bidder wishes to submit the Bid Security in the form of cash, the cash should be deposited in Deposit Account No. (A/C No. 062000028CA, Office Name : Office of Raksirang Rural Municipality, Bank Name : Citizen Bank International, Manahari Branch) and submit the receipt of the deposited amount of cash along with the bid.
8. If the last date of purchasing, submission and opening falls on a government holiday then the next working day shall be considered as the last day.
9. Bidders are advised to visit site and assess the actual site conditions before submitting their bid.
