- 4. Pre-bid meeting shall be held at RAKSIRANG RURAL MUNICIPALITY, CHAINPUR, MAKAWANPUR at 12:00 PM on 2076/7/28.
- 5. Electronic bids must be submitted through PPMO website www.bolpatra.gov.np/egp on before 12:00 PM on 2076/08/8. Bids received after this deadline will be rejected.
- 6. The bids will be opened in the presence of Bidders' representatives who choose to attend at 14:00 2076/08/08 at the office of RAKSIRANG RURAL MUNICIPALITY, CHAINPUR, MAKAWANPUR. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in.pdf format in case of e-bid, amounting to a minimum of as prescribed in table which shall be valid for 30 days beyond the validity period of the bid.
- 7. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
- 8. The bid security guarantee shall confirm to the standard format as specified in the bid document and that issued only by the commercial bank approved by Nepal Rastra Bank shall be accepted by the employer. The details of the contract is given below.
